- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "Economic Empower-
- 5 ment Through Predevelopment Act of 2023".
- 6 SEC. 2. PREDEVELOPMENT GRANTS.
- 7 (a) Predevelopment Grants.—
- 8 (1) IN GENERAL.—Title II of the Public Works
- 9 and Economic Development Act of 1965 is amended

1	by inserting after section 207 (42 U.S.C. 3147) the

3	"SEC. 208, PREDEVELOPMENT GRANTS.
4	"(a) PREDEVELOPMENT GRANTS.—On the applica-
5	tion of an eligible recipient, the Secretary may make
6	grants or cooperative agreements for—
7	"(1) community asset mapping;
8	"(2) training;
9	"(3) technical assistance and organizational de-
10	velopment;
11	"(4) feasibility, environmental, and market
12	studies;
13	"(5) demonstration projects;
14	"(6) organizational capacity building;
15	"(7) organizing and facilitating convenings;
16	"(8) permitting, including professional services;
17	and
18	"(9) other predevelopment activities determined
19	by the Secretary to be appropriate.
20	"(b) APPLICATION ASSISTANCE.—In the case of a
21	project under this section that provides assistance to 1 or
22	more eligible recipients with low organizational capacity,
23	[as determined by the Secretary,] the Secretary may
24	waive the prohibition under section 213.".
