RESOLUTION

Condemning the brutal Hamas-led terrorist attack on the State of Israel on October 7, 2023, and supporting an outcome that ensures the forever survival of Israel, the complete denial of Hamas's ability to reconstitute in the region, and the release of all the remaining hostages from the Gaza Strip, including two United States citizens.

Whereas Hamas is a United States-designated foreign terrorist organization whose founding charter states a commitment to destroying the State of Israel and any nation that would support it, including the United States;

Whereas, on October 7, 2023, Iran-backed Hamas terrorists led an attack on Israel that included the murder of an

estimated 1,200 individuals, including 40 United States citizens, the taking of 251 individuals hostage, and the launching of thousands of rockets into Israel;

Whereas Israel has the same right to defend itself as any other sovereign nation;

Whereas, after continued hostilities by Iranian proxies, Israel launched operations to defend its people, eradicate Hamas terrorists, and rescue hostages being held in the Gaza Strip; and

Whereas Iran-backed Hamas has repeatedly broken negotiated cease-fire agreements and initiated attacks against Israel: Now, therefore, be it

13	burned, and replaced with Hamas flags; and
14	(C) the safety of Jewish Americans has
